

SISTLA KAMESWARI YOUNG SCIENTIST AWARD

Nominations are invited from the members of the Catalysis Society of India for Sistla Kameswari Young Scientist Award. The guidelines and conditions for the award are as follows:

- The nominees should be below the age of 40 years as on 31st December 2017.
- The award will be judged by a panel of three members on the basis of nominations/applications received.
- The work will be evaluated on the following points (i) publications (ii) fabrication design/development work (iii) the impact of the work in the Indian catalysis scenario, and (iv) patents taken.
- The work considered for the award should have been carried out in India
- The awardee may be required to give a presentation of the considered studies for the award either in the national or in local chapter seminars.

Nominations (Preferably Soft Copies) for the award have to be forwarded to the Catalysis Society of India with all supporting documents duly nominated and seconded on or before **31 October 2017**.



Rev Fr L YEDDANAPALLI BEST THESIS AWARD

The Catalysis Society of India (CSI) gives the **Best Thesis Award** in the name of **Rev Fr Lourdu Yeddapanalli** in the field of catalysis. This year the award will be given during the 23rd National Symposium on Catalysis to be held at Royal Orchid Convention Center, Bengaluru during 17-19 January 2018.

The conditions are as follows:

1. The LMY award of the CSI for a particular year will be for the best Ph D thesis that has been awarded a degree in the preceding year (this time 2016 & 2017, since the conference was delayed). The award is to be given each year, either in the symposium or a workshop.
2. The selection of the award will be on the basis of the novelty of the work and the number and the quality of the publications/patents arising out of the thesis work.
3. The nomination for this award is to be forwarded by the research guide/head of the institution.
4. The submission should include the following details:
 - i. Brief summary of the thesis in two to three pages - highlight the new findings of the thesis
 - ii. Bio-data of the candidate
 - iii. Complete list of publications
 - iv. List of papers arising from the thesis work in case different from list in no. (iii)
 - v. A note from the research guide indicating the nominees contributions in the research papers vis-à-vis other co-authors, if any.
 - vi. A certificate from the university regarding the award of the degree
 - vii. Three reference letters (not mandatory) and one of them need to be the research supervisor (must)
 - viii. An electronic version of the PhD thesis including all above information.
